TRANSPARENCY ON WHY WE NEED EMAILS

We are bound by our governing documents on what we can, and cannot, do. Last year, a legislation was passed that can actually help us to share information and vote electronically. Which means, in lieu of spending \$7,000 on postage like we did this last year, we can use email instead.

We need 67% to make changes to our documents. Many residents have asked for a Renter’s Restriction vote, which we held previously but did not receive enough votes to pass. – We can’t make any of these changes, unless enough show up to vote; we believe more vote if electronic voting was an option, don’t you?

Brandon Oaks has 1,346 homes and we’ve received a little over 300 emails – We need at least 902.

Annual Dues



Dues are increasing by 10% for the 2024 year (announced November 2023 Open Meeting). Our new dues amount is \$623.70. 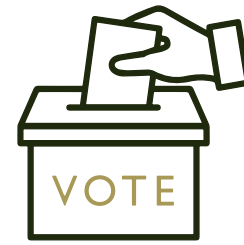
Town Hall Meeting

- Monitoring the irrigation system and reporting any malfunction
- Report deficiencies to the on-site director, Donnie Radcliffe

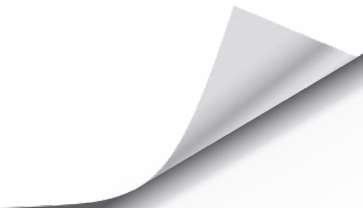
Tree Removal for Road Widening Project

The HOA board is aware of the trees being taken down at our front entrance. It is an unfortunate situation as the trees at the front of our neighborhood helped to provide a beautiful entrance to our community.

Brandon Oaks has been in an eminent domain situation with our front entrance and the widening of Old Monroe Road. We have been in contact with our lawyer again; she has advised us that because of eminent domain, they are within their rights to remove the trees.

Please be careful when coming into and out of our neighborhood as the trees are being removed. Be mindful driving down Old Monroe Road as well, as this project does extend down a good bit.

Bulk Waste refers to items too large to fit into your recycle or garbage carts such as appliances, furniture, or bicycles.

Your items will be collected on your regularly scheduled recycling collection day only.

You do not need to schedule your pick-up for this special service offered curbside four times each year. All items must be placed curbside by 7 AM of your regularly scheduled service day of your recycling week. For additional questions, contact Please contact God Bless USA at 704.708.5872.

[View Acceptable Items](#)

Guidelines for Efficient Curbside Collection

- All bags must fit inside Town of Indian Trail authorized roll-out garbage carts
- Collections are made between 7 a.m. and 7 p.m.
- Garbage and Recycling carts should be positioned at the curb with wheels and handle away from the street
- Leave at least 3 feet between the carts.
- Household hazardous waste is not allowed for disposal
- Please place carts at least 3 feet from obstacles
- Residential trash/garbage must be placed in tied bags and placed in beige cart
- Residents are issued one beige roll-out garbage cart and one blue recycle cart per household
- Additional trash carts are provided at an additional cost

Designation of Email Address

N.C.G.S. § 55A-1-70

Pursuant to N.C.G.S. § 55A-1-70, the undersigned Member of the Association hereby designates the email address below for the purpose of communicating and conducting business with the Association to the fullest extent permitted by law, to include, without limitation, the receipt of official notices from the Association and solicitations for electronic voting.

Once designated, the Association is entitled to and will rely upon the email address designated by the Member. It is the Member's sole responsibility to monitor and maintain control over the designated email address, and the Association is NOT responsible for failure of delivery or failure of the Member to receive any message which is properly addressed to the Member's designated email address. It is the Member's responsibility to ensure that no "spam" or "junk" email filter intercepts any message(s) or other communication(s) sent by the Association.

In order to update the designated email address specified herein, the Member must contact the Association in writing to request a new Designation of Email Address form and must complete and return that form to the Association as instructed by the Board or the Association's property management agent. The Association will rely on the most recent Designation of Email Address form for the Member which is properly filled-out by the Member and actually received by the Association.

The Association may also use the Designated Email Address below to communicate with the Member regarding any delinquent amounts owed to the Association. The Association may provide the Designated Email Address to the manager, attorney or debt collector engaged by the Association to collect past due amounts owed to the Association and the manager, attorney or debt collector may use the email address to communicate with the Member regarding the debt. If others have access to the email, it is possible they may see these communications. If you wish to opt out of these communications, you must contact the Association in writing within thirty-five (35) days of the date this notice was sent to you to inform the Association of your desire to opt out of such communications.
